Dear Parent / Caregiver

It is planned that students in Years 3 - 6 and Year 2 students who will turn 8 this year will participate in our annual Swimming Carnival at Swansea Pool on Tuesday 12 February 2013.

**Transport** will be by parent organised means, leaving at 8.45 am and returning at approximately 2.45.

**The cost** of entry into Swansea Pool is \$2.60 for each child payable to the school. If your child has a current pool pass – please quote your pass number on the permission slip. The entry fee for all spectators and parent helpers is \$2.50, payable at the pool gate.

**Permission notes and money** need to be returned to the office by Friday 8 February 2013.

**Supervisors** will be classroom teachers.

**Parent helpers** will be required for time keeping, recording and novelty events.

*All helpers will have to have signed the Prohibited Employment Declaration required under the Child Protection (Prohibited Employment) Act 1998.*

**Requirements:** Swimmers, towel, hat, sunscreen, water bottle, lunch and recess. Students are encouraged to attend wearing their sporting house colours.

**Additional Information:** The Pool canteen will be open for some purchases.

The carnival will go ahead regardless of the weather.
