- 1. I understand and acknowledge that participating in the ObstAcool event organized and conducted by Cool Kids Events Pty Ltd is a dangerous activity and as such it has inherent dangers and risks. The Event may involve climbing, running, crawling, following directional signage and independent decision making. I am aware of the hazards involved and acknowledge that there is always risk of injury (in extreme cases including permanent injury, mental injury, paralysis and death). In my judgment the child in my care has sufficient competence, experience and equipment to participate in all Obstacool activities in a manner safe to themselves and others.
- 2. I further acknowledge and agree that due to the nature of the activity, it would be unreasonable for Cool Kids Events Pty Ltd to be in any way responsible for any injury to or death of a participant.
- 3. I further acknowledge and agree that I am allowing a child under my care to be undertaking the activity freely, voluntarily and absolutely at our own risk and with a full appreciation of the nature and extent of all risks involved in the activity.
- 4. In consideration of being allowed to participate in Obstacool, I on behalf of the child in my care
  (a) WAIVE, RELEASE AND DISCHARGE, to the full extent permitted by law, from any and all
  liability for death, disability, personal injury, property damage, property theft, any other loss
  and/or damages and all other risks, claims or actions of any kind (including breach of
  contract, any negligent or tortuous act or omission, breach of duty or breach of statutory
  duty) whatsoever and however occurring, together with any legal fees incurred as a result of
  any such claim whether it is valid or not, which I at any time had or have as a result of or in
  connection with, directly or indirectly, my participation in and my travelling to and from the
